Re: Clery Act Violations by The Pennsylvania State University - Daily Crime and Fire Log

To whom it may concern,

This is a complaint regarding repeated and ongoing violations of the Clery Act by The Pennsylvania State University. I am an undergraduate student at Penn State University and I am making this complaint based on my personal knowledge and observations. I submit this letter in full awareness of the penalties of 18 U.S.C. § 1001.

Penn State University has repeatedly refused to provide historical access to Daily Crime Log and Daily Fire Log records, in violation of their obligations pursuant to 20 U.S.C. § 1092(f) and 34 CFR 668.46(f)(5). I am aware of at least three instances of this type of violation, but I believe that there may be more.

#### Known Violations

On requested by email historical access to Daily Crime Log and Daily Fire Log records. On University Police and Public Safety Records Specialist wrote, "[w]e cannot provide any further information besides what is available to the public on the 60-day crime log."

Thursday, September 7th, 2023 -

On September 7<sup>th</sup>, 2023, Penn State University graduate student requested by email historical access to Daily Crime Log and Daily Fire Log records from the period of May 1<sup>st</sup>, 2023, to September 7<sup>th</sup>, 2023.

On September 8th, 2023, University Police and Public Safety Records Unit wrote, "[t]he crime logs are available for 60 days prior to the current date. Those are the only logs available to the public."

# Monday, September 11th, 2023 - Nicholas Rizzio

On September 11<sup>th</sup>, 2023, I wrote a certified letter to the Clery Compliance Coordinator requesting historical access to Daily Crime Log and Daily Fire Log records from the period of August 1<sup>st</sup>, 2019, to September 11<sup>th</sup>, 2023. I sent the letter to 30 Eisenhower Parking Deck, University Park, PA 16802, which is listed as the official address of the Clery Act Coordinator for the university.<sup>1</sup>

On September 13<sup>th</sup>, 2023, the certified letter was received, and the return receipt was signed by the university. As of October 9<sup>th</sup>, 2023, I have not received any response from the university whatsoever regarding my request.
